## **Tuition and Financial Commitment**

### **APPLICATION, ENROLLMENT & REENROLLMENT FEES**

The application fee is due when the online application is submitted, and the enrollment fee is due when the online enrollment is submitted. Students will not be considered accepted (guaranteed a seat) until both the online application, enrollment, and payments have been submitted unless arrangements are made with administration. See fees listed below.

New Student Application Fee: \$22

New Student Enrollment Fee: \$185

Early Re-enrollment (by January 31, 2026): \$22

Re-enrollment (submitted after January 31, 2026): \$135

*\*Application/Enrollment/Re-enrollment fees are non-refundable.*

### **BILLING INFORMATION**

TBA processes all payments through FACTS Tuition Management. Due to the scholarships available to Arizona families, tuition is billed on a quarterly basis and is due by the end of each quarter. Any incidental fees, will be billed directly through FACTS as they arise.

## LATE FEES

Tuition is due upon receipt of invoice. A late fee of \$75 will be applied to any account not paid in full by the end of the quarter unless arrangements have been made with School Administration prior to the due date.

## BEFORE AND AFTER SCHOOL CARE

Before Care	6:30 AM-7:30 AM	\$8/day/student
General Drop-Off	7:30 AM-8:00 AM	No charge.
After Care	3:15 PM-6:00 PM	\$8/hour/student

*\*All students K5-12<sup>th</sup> grade should be picked up by 3:15 PM. Those students who are not picked up by this time will automatically be sent to After Care and charged accordingly.*

After Care billing does not begin until 3:30 PM. Students picked up after 6:00 PM will be charged \$5.00 for the first 15 minutes and then \$1.00 per minute thereafter.

## SPECIAL INFORMATION

- Students will not be allowed to reenroll if there is an outstanding balance due.
- Application, Enrollment, and Reenrollment fees are nonrefundable unless the student fails to meet admission requirements.
- No financial adjustments are made for student absences or family vacations.
- Students attending one or more days of any quarter owe that quarter's full tuition.

## **Financial Commitment:**

1. I/we understand that the Application and Enrollment Fees are non-refundable.
2. I/we agree to pay the tuition based on a quarterly plan with the last payment due on or before **June 1, 2027**.
3. I/we understand that a charge of \$75 will be assessed to accounts not paid by the scheduled due date unless otherwise discussed with Administration.
4. I/we understand that if we withdraw our student(s), we are responsible for paying the full tuition amount due for the remainder of the quarter.
5. I/we understand that if our account is one quarter delinquent that the result will be a late fee of \$75 or the withdrawal of our student(s) from school until the account is current, or acceptable arrangements have been made with Administration.
6. I/we understand that in the event that our account should remain delinquent after the said time in point 5, and upon the discretion of Tucson Baptist Academy, our account may be turned over to small claims court for collection or judgment.
7. I/we understand that accounts must be current in order to receive and continue receiving Financial Aid.
8. I/we understand that there will be a \$25 charge for any check returned to the school by the bank.
9. I/we recognize that tuition and fees do not cover the total cost of educating our children for the time attended. Therefore, we will prayerfully consider what our family will do to contribute in addition to our payments (Tax Credit, Annual Fund Appeal, etc.).
10. I/we understand that student records will not be released if there is an outstanding balance owed.
11. I/we understand that my student cannot reenroll for the next school year if there is an outstanding balance owed.
12. I/we understand that if my student is utilizing STO funds, that those funds are only for the use of covering tuition costs and any other fees or balances cannot be paid for with STO funds.
13. I/we understand that our child will not be able to begin school until this form has been signed and returned to the school office.
